Purpose:

Goodwill of the Great Plains is requesting the Region 12 Local Workforce Development (LWDB fka RWIB) and Chief Elected Officials (CEO) Boards transition the TTW funds from the State of Iowa's EN to Goodwill of the Great Plains' EN.

Background:

In about 2012 Goodwill of the Great Plains was selected to be the fiscal agent in Region 12-Sioux City for a Department of Labor (DOL) Disability Employment Initiative (DEI) grant received by the State of Iowa and Iowa Workforce Development (IWD). Region 12-Sioux City was one of five regions in the state selected to receive funds from the DEI grant. The purpose of the grant was to enroll individuals with "tickets" as so deemed by the Social Security Administration (SSA). The goal was to assist individuals on Supplemental Security Income (SSI) or Social Security Disability Insurance (SSDI) get off disability and into long-term, self-sustaining employment. Once an individual reached certain milestones in their employment, the Employment Network (EN) would then be rewarded or incentivized with Ticket to Work (TTW) payments.

At the time the grant was awarded to the state, the Region 12 Regional Workforce Investment Board (RWIB) selected Goodwill to be the fiscal agent for the funds for the State of Iowa/Iowa Workforce Development's EN. The grant was funded a second time to the same five regions and officially ended on March 31, 2019. Two of the original regions, Region 11-Des Moines and Region 16-Burlington, received the TTW funds in to local ENs from the beginning of the grant.

Since the end of the grant in 2019, the Boards in Region 7-Waterloo and Region 3/4-Spencer voted to transition the TTW funds received for their individual regions from Iowa's EN to a local EN. The purpose of this transition is to ensure local control of the funds and continued support of the Disability Resource Coordinator (DRC) that is employed by the local fiscal agent. The DRC is an individual originally hired under the DEI grant to enroll and support individuals in the region with and without "tickets" find employment and locate resources to help them overcome barriers and challenges to employment.

Goodwill of the Great Plains continues to serve as the fiscal agent for Region 12-Sioux City. Local control of the funds is necessary to continue serving individuals both with and without 'tickets" via the DRC. IWD and the WIOA core partners now need to approve any and all expenditures of the funds as they are under the State of Iowa's EN following the end of the DEI grant.

It is the intent of Goodwill to continue serving individuals with disabilities in the region regardless of "ticket" assignment through Goodwill's EN and future TTW funds as they are received. The funds will be used to support the DRC and related costs to include though not limited to rent, especially at the lowaWORKS office in Sioux City, as well as other reasonable costs related to assisting individuals gain successful, long term employment. The transitioning from IWD's EN to Goodwill's EN will ensure local control and access to the supports needed in the region to help those who are trying to return to employment and reduce or eliminate their need to receive disability payments. Goodwill of the Great Plains will provide Ticket to Work reports as requested by the LWDB board in order to maintain transparency and ensure the partnership between Goodwill and the LWDB remains strong.
