Welcome by Lynn Shreder, Chair.

- Welcome to new State Board members.
- Youth Apprenticeship Readiness Grant the Urban Institute (Washington, DC) has applied for this grant, and the State Board will be supporting the Urban Institute in its efforts if the grant is received.

Presentation on updates and guidance on monitoring and compliance in light of COVID-19 received from Region 5, by Division Administrator, Michelle McNertney, Iowa Workforce Development.

• IWD was to begin monitoring of local areas beginning in PY20 (July 1, 2020), but as a result of the COVID-19 pandemic, IWD (with the support of USDOL) has pushed back this start date to later into PY20. No questions from State Board members.

Presentation of consolidation proposals by CEOs from local regions and regarding the financial and background information by Division Administrator, Michelle McNertney, Iowa Workforce Development.

- Reviewed the documents provided to State Board members.
- Reviewed the background/timeline of Iowa's attempts to realign local areas.
- Reviewed WIOA requirements for local area consolidation.
- Reviewed funding allocation formulas.
- Reviewed the 4 consolidation requests:
 - Regions 1, 2, 7 = Northeast Iowa
 - Dave Baker, CLEO
 - \circ Regions 8, 12, 13 = Western Iowa
 - Wayne Miller, CLEO
 - \circ Regions 6, 15 = South Central Iowa
 - Jason Roudabush, CLEO
 - Regions 9, 16 = Mississippi Valley Iowa
 - Jack Willey, CLEO
 - Brad Quigley, CLEO
- Rob Denson stated that the consolidation requests look good, and then asked if the new areas satisfy the realignment committee's requirements for funding? Answer:
 - Funding will not be less than 90% of previous year.
 - List of funding for 2020 will be shared after today's vote.
- Question (unknown board member): Is further consolidation anticipated after today's vote? Answer:
 After today's vote, more consolidation is possible, but unlikely in the near future.
 - Rich Kurtenbach asked if Regions 6, 15could function as a new local area given the large size? Answer:
 - Jason Roudabush confirmed that the existing regions work well together, and all are in favor of the request to consolidate.
- Charlie Wishman asked if consolidating regions will result in any closure of offices? Answer:
 No
- Drew Conrad asked if the \$100K threshold for administrative funding has been met? Answer:
 There are no thresholds because the requests for consolidation are voluntary.
- Jack Willey thanked Michelle McNertney, Linda Rouse and the IWD team for their training and support.

Director's Report by Director, Beth Townsend, IWD.

- Highlighted the IWD team's accomplishments and expressed gratitude for all their efforts. Described the increase in workload over the last 2 months, mandatory overtime, and redistribution of personnel to support efforts. 6 outside state agencies are also helping with Unemployment Insurance (UI) Customer Service and Claims Processing.
- Discussed Federal CARES Act, signed March 27, 2020 by President Trump. Presented overview of the following benefits:
 - Pandemic Unemployment Assistance (PUA)
 - Pandemic Emergency Unemployment Compensation (PEUC)
 - Federal Pandemic Unemployment Compensation (FPUC)
- Discussed UI Trust Fund. Current balance = \$983 million
- 1st Quarter Tax Deferment to July 1, 2020 was only taken by a very small amount of businesses eligible.
- Constantly updating website with webinars, FAQ, and information in 10 different languages.
- Jessica Dunker publicly commended IWD for rapid response and job well done.
- Charles Wishman asked: Do you have any idea when field offices will reopen and what will the safety measures include?
 - Ryan West is leading an internal planning task force that will consider these issues. At this time, we are not planning to reopen soon because field office staff have been redirected to other areas. We still continue to be open by appointment only.
- Jessica Dunker asked: Has IWD been notified of people refusing to return to work and how is that being handled?
 - Fact-finding interviews are taking place. If determined that a claimant is high risk/medically unable to go back to work, his/her claim will transfer to from State UI to Cares Act benefits.

Update on Disability Access Standing Committee by David Mitchell, Administrator of Iowa Vocational Rehabilitation Services (IVRS) and Chairperson of the Disability Access Committee.

• Working on quality improvement and reviewing how services are integrated across Core Partners to assist people with disabilities. Will provide follow-on updates to the State Board.

Update on Ex-Offender Reentry and Minority Unemployment & Outreach Committees by Deputy Director, Ryan West, Iowa Workforce Development.

• On hold at the moment due to COVID-19. Will reconvene Committee in June or July.
