New Business: Determining next steps for the State DAC and its work going forward.

- Question: What is next for Iowa Workforce Changes New Iowa Plains and the impact on DAC going forward:
 - Keeping offices in Sioux City, Ft. Dodge, Spencer, Creston, and Council Bluffs. There will be opportunities here for DAC work, this will process as we all continue forward.
 - \$700,000 combined Ticket to Work funds.
- DAC Priorities
 - AJC Accessibility: work to have accessible spaces, as well as any training, and support to facilitate service delivery. Establish Core levels of Assistive Technology.
 - Facilitate Community of Practice
 - Employer Engagement: Value adds for employers. Establish Employer recognition: Annual awards like NDEAM, APSE, but creating other annual awards that work to nominate and highlight inclusive employers provide marketing and publicity which also incentivizes this work. NDEAM-October 2024 timeline. Service delivery: Working to provide training and a more uniform experience for employers by improving consistency, timing of, and cross-training of expertise of those working to provide services under business engagement.
 - DAC Engagement Recruitment: assistance, TA, reference materials/tools, idea sharing. Retention benefits: information sharing, education, marketing, networking, etc.
 - Training and Integrating Employment
 - This would be the community of practice and a way to create engagement from the local boards to each other, as well as a way for the state DAC to put out training sessions and technical assistance to the locals.
 - State DAC would like to involve Kathy Anderson: Business Engagement, per Rouse's suggestion. She has been invited to the upcoming meetings.

- Discussion on the Windmills training and the follow up training that is coming soon.
- DAC Success Story: Iowa Workforce Development might be a home for these employer spotlights. Already have a template and form for AJC, could possibly use the same template for DAC. Here for review._
