**Subject:** Conflict of Interest Policy

#### **Purpose**

- 1. The purpose of this policy is to provide guidance on conflict of interest in the Iowa Plains Workforce Innovation and Opportunity Act (WIOA) Title I Program.
- 2. Iowa Plains is committed to maintaining the highest of standards of ethical conduct and to guard against problems arising from real, perceived, or potential conflict of interest.

## **Background**

- Grantees, sub-recipients and contractors funded under WIOA must implement codes of conduct and conflict of interest policies and procedures as stipulated in WIOA law, regulations and guidance; State regulations; and State WIOA policies. A conflict of interest policy is required to ensure that individuals or representatives of organizations entrusted with public funds will not personally or professionally benefit from the award, administration, or expenditure of such funds.
- In addition, the Iowa Plains Executive Committee recognizes that by its very composition, conflicts of interest and issues concerning the appearance of fairness may arise. Therefore, it is essential for the Iowa Plains Executive Committee members and members of its standing committees to be sensitive and err on the side of caution when potential or real conflict or fairness matters occur.
- 3. To accomplish these purposes, the Iowa Plains Executive Committee establishes the following definitions, actions, and guidelines for interpretation.

#### **Guidelines for Interpretation:**

Areas of concern are those actions or lack of actions, which may lead to conflict of interest or the appearance of conflict of interest or to a perception of unfairness related to Iowa Plains Executive Committee business outside committee meetings. Specific areas which may pose problems include but are not limited to, comments made in public, information sharing, and disclosure of associations.

**Comments Made in Public**: Iowa Plains employees, Iowa Plains Executive Committee and committee members are encouraged to act in a public relations capacity for Iowa Plains Local Workforce Development Area. This includes public speaking engagements and comments in a public forum. Because there is interest in Iowa Plains Executive Committee actions, members

should differentiate between descriptive comments, which relate to actions already taken by the Iowa Plains Executive Committee, and statements, which imply future Iowa Plains Executive Committee decision-making, or the ability to influence decision-making.

**Information Sharing:** Iowa Plains Executive Committee and committee members are encouraged to share information with the community about Iowa Plains Local Workforce Development Area activities. To the extent possible, access to information regarding procurement of services should be available at the same time and under the same circumstances to all parties. Such information includes the request for proposals, notice of meetings, meeting minutes, and policies.

**Disclosure of Associations**: Iowa Plains Executive Committee and committee members have professional and personal associations throughout the community. Such associations have been and will continue to be of significant benefit to Iowa Plains Local Workforce Development Area. Where a direct or indirect financial conflict of interest exists, an Iowa Plains Executive Committee or committee member may not vote or serve on a rating team. When associations raise appearance of fairness as an issue, Iowa Plains Executive Committee and committee members should qualify statements in public by disclosing the association and minutes of the meeting should reflect the disclosure.

### **Conflict of Interest Policy**

- 1. Each grant recipient and sub-recipient must maintain a written code of standards or conduct governing the performance of persons engaged in the award and administration of WIOA contracts and sub grants.
- 2. No individual in a decision-making capacity shall engage in any activity if a conflict of interest (real, implied, apparent, or potential) is involved. This includes decisions involving the selection, award, or administration of a sub grant or contract supported by Workforce Innovation and Opportunity Act (WIOA) or any other federal funds.
- 3. An Iowa Plains Executive Committee member or a member of a sub-committee cannot cast a vote or participate in any decision-making about providing services by such member (or by any organization that member directly represents) or on any matter that would provide any direct financial benefit to the member or to the member's organization.
- 4. Before any public discussions regarding the release of a Request for Proposal, or any matter regarding the release of funding or the provision of services, an Iowa Plains Executive Committee member or a member of a board committee must disclose any real, implied, apparent, or potential conflicts of interest before engaging in the discussion. The minutes of the meeting should reflect the disclosure.
- 5. Iowa Plains Executive Committee members or a member of a board committee or agents of the agencies making awards cannot solicit or accept gratuities, favors, or anything of monetary value from awardees, potential awardees, or other parties to agreements.

- 6. Disciplinary actions may be taken up to and including termination of Iowa Plains Executive Committee membership for violation of this policy by any individual. The Iowa Plains Executive Committee may evaluate any violations of these provisions on a case-by-case basis and recommend to the Iowa State Workforce Development Board, if and what penalties, sanctions or other disciplinary action are appropriate.
- 7. Individuals shall not use for their personal gain, for the gain of others, or for other than officially designated purposes, any information obtained as a result of their committee or working relationships with the Iowa Plains Executive Committee where that information is not available to the public at large, or divulge such information in advance of the time decided by the Iowa Plains Executive Committee for its release.
- 8. One Stop Operators must disclose any potential conflicts of interest arising from relationships with training providers and other service providers. [WIOA Section 121 (d)(4)]
- 9. Any organization that has been selected or otherwise designated to perform more than one function related to WIOA must develop a written plan that clarifies how the organization will carry out its multiple responsibilities while demonstrating compliance with WIOA, corresponding regulations, relevant Office of Management and Budget circulars, and this conflict of interest policy. This plan must limit conflict of interest or the appearance of conflict of interest, minimize fiscal risk, and develop appropriate firewalls within that single entity performing multiple functions. The plan must be agreed to by the Iowa Plains Executive Committee
- 10. Membership on the Iowa Plains Executive Committee, or being a recipient of WIOA funds to provide training or other services, is not itself a violation of conflict of interest provisions of WIOA or corresponding regulations.
- 11. Iowa Plains Executive Committee Members must disclose any conflicts or potential conflicts to the LWDB Executive Committee within five business days of said conflict. Declarations can be made using the Conflict of Interest Declaration Form (Attachment A).

#### **Definitions**

Conflict of Interest - Conflict between the official responsibilities and the private interests of a person or entity that is in a position of trust. A conflict of interest would arise when an individual or organization has a financial or other interest in or participates in the selection or award of funding for an organization. Financial or other interest can be established either through ownership or employment.

*Immediate Family* - Immediate Family consists of the individuals' parents (including step-parents), spouse, domestic partner, children (including step-children), siblings, grandchildren, and grandparents.

*Individual* - (1) an individual; i.e., officer, or agent, or (2) any member of the individual's immediate family (spouse, partner, child, or sibling), or (3) the individual's business partner.

Organization - A for-profit or not-for-profit entity that employs, or has offered a job to, an individual defined above. An entity can be a partnership, association, trust, estate, joint stock company, insurance company, or corporation, whether domestic or foreign, or a sole proprietor.
