Director's Report - Beth Townsend

Director Townsend reviewed the handouts provided in the board packet and the additional items provided at the meeting.

Director Townsend briefed the State Board on IWD personnel changes. Director Townsend introduced Cathy Ross as the new PMO manager and Marketa Oliver as the new Workforce Services Division Administrator. Director Townsend announced the retirement of Joe Bervid, effective December 31, 2015. Ben Humphrey will be the new State Board Attorney. Director Townsend also announced Ted Schoonover, the former IWD Program Manager, is no longer with IWD. Director Townsend is working to fill the Program Manager vacancy.

Director Townsend and senior staff presented to the Iowa General Assembly's Economic Growth Appropriations Subcommittee on February 5, 2016. IWD is requesting no changes to the 2017 FY budget.

There will be three State Board vacancies by May 2016. All three replacements are required to be filled by women to maintain board balance. The three areas that need to be filled are a business representative, a labor representative and a non-profit representative. Director Townsend asked that if any board members had recommendations to fill any positions, to please contact either her or Deputy Director Wallace.

Director Townsend addressed the issue of the importance of regular meeting attendance from all board members. Not having a quorum at meetings is counterproductive to board business. Director Townsend encouraged all board members to participate in board meetings either in person or via conference call.

Director Townsend has been meeting to connect with partners from across the state in education. Director Townsend has been meeting with Iowa Community Colleges, Universities, the Department of Education, and the School Administrators Association (SIA) group. Director Townsend attended a SAI meeting in December which brought together education, business and industry leaders for a roundtable discussion. Director Townsend is working on improving communication with the private colleges.

IWD is continuing to work on the WIOA State Unified Plan. Director Townsend thanked all of the partners and IWD staff who have been working on the plan.

Legislative Update – Ed Wallace

As a follow up to the directors report IWD has requested the 2017 FY budget to remain the same.

Deputy Wallace is working closely with Senator William Dotzler on a bill that will be introduced through the Senate Appropriations Committee that would authorize the use of the federal Reed Act funds to modernize IWD's 1974 legacy unemployment insurance benefits system. The bill will also include federal Workforce Innovation and Opportunity Act (WIOA) conformity langue.

Budget Update – Paul Mikkelsen

Paul reviewed the Iowa Workforce Development Foundation Report and the Iowa Workforce Development Board Report handouts previously provided in the Board packet.

There are not any significant issues or items to report. Paul projected IWD will end the State FY2016/17 in good financial standing.

Paul gave the Annual Financial Foundation Report. There were very little changes from last year. There are not any significant issues or items to report.

JD NEG Grant Update - Jeff Chamberlin

Jeff implements the federal United States Department of Labor (USDOL) Job Driven National Emergency Grant (JD NEG) grant for the state of Iowa which totals \$6.175 million. The grant funds are designed to work for apprenticeship driven jobs across the state. Many of the programs outlined in the Governor and Lt. Governor's presentation are a direct result of the JD NEG grant. One of the biggest components to this grant are the funds are used for rapid response to areas that are being impacted by layoffs and closures.

Fraud, Detection, Debt/Collections Update - Ryan West

Ryan presented to the board a Debt Resolution Overview and Plan. Ryan reviewed the handout previously provide to the board in the board packet.

IWD currently has \$162,268,313.74 in employee tax debt and \$50,000,000 in Claimant benefit debt on the books. The presentation outlined the plan IWD would like to implement over the next 12 months. The presentation outlined a list of actions IWD would like to put into place to start collecting employer tax debt and then collecting claimant benefit debt.*

Misclassification Unit Update - Ben Humphrey

Ben Humphrey reported on the challenges of staffing the Misclassification Unit. As part of an IWD Unemployment Insurance Division reorganization, the Misclassification Unit is being placed under the supervision of an investigation manager as a part of a unit that also includes the unemployment insurance fraud unit. Both of the units do similar investigations and both units address both types of fraud. The unit is currently in the process of hiring a manager and expanding the number of positions of investigators.

Workforce Innovation and Opportunity Act (WIOA) Update – Ben Humphrey

IWD, Iowa Vocational Rehabilitation Services (IVRS), Iowa Department for the Blind (IDB), and the Department of Education, Adult Education and Literacy (IDOE), are the State of Iowa's Core Partners under WIOA. Since the last WIOA briefing at the November 2015 meeting of the State Board, the Core Partners have continued their WIOA implementation efforts. This has included training, outreach and consultation with WIOA Required Partners and stakeholders, and Work Group meetings to finish the Unified State Plan.
