# Federal Disaster Flood Declaration:

Bremer County requested plan was submitted to state last Thursday, still awaiting approval. Buchanan County was added to the declaration recently so working with county officials to assess damage and decide on plan.

# Regional Realignment: State Workforce Development Board Meeting Discussion

Linda updated the board on the information she had from a couple phone discussions and the actual SWDB meeting held on May 30. Such as, the board not hearing all appeals only a

couple were able to discuss appeal and reasons for their appeal. The state board then voted to deny all appeals and move forward with plan. A subsequent CEO statewide meeting was held and those in attendance were given copies of the different appeals, hundreds of pages from just one regional CEO. Linda asking R7 board members if they would like to sign on to the statewide appeal and would they sign a letter of appeal to be added to statewide appeal. After discussion there was a consensus to include entire R7 board signatures on letter to be sent and included on the statewide realignment appeal.
